

# GENERAL ELECTION TO LOK SABHA OF 1- WEST TRIPURA PC & BYE-ELECTION OF 7-RAMNAGAR ASSEMBLY CONSTITUENCY -2024



## APPEAL TO VOTERS FOR POLLING DAY

All the concerned voters for 1-Tripura West Parliamentary Constituency & Bye Election of 7-Ramnagar Assembly Constituency are requested to cast their votes at the designated polling stations on the 19<sup>th</sup> April, 2024 (Friday) from 07.00 A.M. to 05.00 P.M. in peaceful manner and without any fear. If there is any issue, kindly contact "Complaint Redressal Officer" assigned for each Assembly Segment, on contact number having whatsapp facility, as per list given. The civil and police administration will respond immediately on getting your call.

*For general information, following legal provisions for obstructing any voter from casting his/her vote on the way to the polling station and maintenance of secrecy of voting in the polling stations, are as follows :-*

### 1. Section 135A (C) of the Representation of People Act, 1951

Coercing or intimidating or threatening directly or indirectly to any elector and preventing him/her from going to the polling station or a place fixed for the poll to cast his/her vote is an electoral offence under subsection (C) of Section 135A of the Representation of the People Act, 1951.

Whoever commits such offence shall be punishable with imprisonment for a term which shall not be less than one year but which may extend to three years and with fine.

### 2. Maintenance of secrecy of voting in the polling stations:-

The Rule 49M of Conduct of Election Rules, 1961 provides that any elector who violates the provision of maintenance of secrecy of voting inside the polling station shall not be allowed to vote.

The Section-132 of the Representation of the People Act, 1951 provides that any person who during the hours fixed for poll at any polling station misconducts himself or fails to obey the lawful directions of the Presiding Officer may be removed from the Polling Station by the Presiding Officer or by any Police Officer on duty or by any person authorized in this behalf by such Presiding Officers.
