NOTIFICATION

WHEREAS the State Government expressed its intention to include the area mentioned in the schedule below with Agartala Municipal Corporation vide Urban Development Department's Notification No.F.2(1)-UDD/DUD/2020/12483-503 dated the 14th October, 2020 as required under section 7 of the Tripura Municipal Act, 1994 as published in the extraordinary issue of Tripura Gazette dated the 14th October, 2020 as required under section 4 of the Tripura Municipal Act, 1994 inviting objection from all inhabitants likely to be effected thereby as required under section 5 of the Tripura Municipal Act;

AND WHEREAS, the said Notification was made available to the public on the 14th October, 2020.

AND WHEREAS no objection has been received from any inhabitants of the area specified in the Schedule below on the said intention of the State Government within the time specified by section 5 of the said Act.

NOW THEREFORE, in exercise of the powers conferred by section 6 of the Tripura Municipal Act, 1994, the State Government hereby constitutes the area as mentioned in Schedule hereto as Agartala Larger Municipal Areas which will be known as Agartala Municipal Corporation.
